#### **PREMISE**

Matco srl company is engaged in the design, production and trade of waterproofing bituminous membranes, but also in the sale of complementary materials and production of coupled panels and chemicals.

In order to better qualify the services offered and in order to obtain complete satisfaction of the needs and expectations of its customers, Matco srl has decided to create and maintain a quality management system in compliance with the UNI EN ISO 9001:2015 standard.

- Collaboration with suppliers to guarantee quality criteria and reduction of environmental impacts.


#### THE SUPPLIERS
